## SUBJECT: RECONSTITUTION OF AND CONCURRENT DESIGNATION AS MEMBERS OF THE COMMITTEE ON DECORUM AND INVESTIGATION ON SEXUAL HARASSMENT CASES (CODI)

<u>05</u>. In the interest of the service, pursuant to Civil Service Commission Resolution No. 01-0940 dated May 21, 2001 otherwise known as the Administrative Disciplinary Rules on Sexual Harassment Cases, which requires the creation of a Committee on Decorum and Investigation (CODI) in all national or local government agencies, state colleges and universities; and, government-owned and controlled corporations, a reconstitution and concurrent designation of the following employees as members of the DA-PHilMech CODI is hereby authorized and made of record effective immediately:

As such, the Committee shall be responsible for the following:

- 1. Receive complaints of possible sexual harassment;
- Investigate sexual harassment complaints in accordance with the prescribed procedures;
- 3. Submit a report of ITS findings and corresponding recommendations to the disciplining authority for decision;
- 4. Lead in the conduct of discussion about sexual harassment within the agency to increase understanding and to prevent incidents of sexual harassment; and,
- 5. Perform other related official functions.

In instances when a member of the Committee is the complainant, or the person complained of in a sexual harassment case, he/she shall be disqualified from being a member of the Committee in the processing of that particular complaint.


